1. North and South Playground Gates
 - a. Concerns with evacuation drills or an emergency and locked gates for easy exit
 - i. District clarified that the gates do not need to be locked during the day for those schools that aren't next to a public park. We won't publicize this, but will let teachers know.
 - b. Kindergarten Playground
 - i. Enclosing sidewalk area between the building and K playground - work request has been made. We are hopeful this will be done before the new school year.
2. New signs have been placed - they are the incorrect signs. Ruth Ann will follow up with this, but it will take some time to correct.
3. Kellie Byars- Social/Emotional update - excused (helping with Second Step lessons)
4. Richard Bell- Custodial update - stage curtains have been cleaned.
5. Playground area is small and confined and presents a behavioral problem with so many students using it. Ruth Ann is hoping to use capital improvement to increase the size of our playground. The committee will be meeting in February. We know they have already planned to use some of these funds to redo our parking areas due to settling. It would be nice to have a redesign of our drop off lanes/parking in conjunction with this. Ruth Ann will work with Kyle Bates about also communicating with the city on this project.
6. Sargent Bascom- SRO update - no new updates from him.
 - a. Questions about how the drop off/pick up is going. He noticed parents ignoring the teacher standing at the crosswalk when he came here. He will be here when he can and also asked for extra traffic enforcement to be here when available.

- **Ashley Rayback moved to approve last month's minutes and Jenny Wright seconded it.**

- **Amendments approved by PCSD Board on Tuesday, January 9**

- 1. Acadience Reading MOY Data Review**

- a. This is a state screening test and it is used for accountability purposes as well. It is a good predictor of reading success/challenges
- b. **SIP Goal #1:** Increase percentage of K-6 students reading at or above benchmark on Acadience by 10% from 54% at BOY to 64% at EOY.
- c. Teachers analyzed this data on our last PD day to determine what is working well and what needs improvement.
- d. We are concerned at MOY because we haven't had the growth we have seen in the past at this point in the year.
- e. **SIP Goal #2:** Increase percentage of K-6 students scoring typical or well-above typical progress on POP by 3% from 72% in 2022-23 to 75%.
- f. Overall school growth is 64% at MOY.
- g. Some challenges this year: Attendance issues, behavioral issues, many new to country students.

- a. Most progress on MOY assessments? 58% - ELA
- b. What is contributing to this growth? - Ruth Ann will share the comments
- c. Areas you see students needing more support to make progress (Reading support comes up a lot.)
- d. What is contributing to the need for support in these areas? (Big theme was "unmotivated" students.)
- e. Which area has the greatest academic need? 68% - ELA
- f. What impact does behavior have on your instruction? Huge impact!
- g. What impact does attendance have on your instruction? Again - huge impact. Our family advocate has really worked hard this year to work with these families but we are seeing a lot of absenteeism this year. We are recognizing classes with great attendance.
- h. Please list other considerations that you would like to share with the SCC as they discuss the academic area of great need in ELA or Math.

- 3. As we're thinking about TrustLand Goals, Ruth Ann is suggesting that we use RISE data as this is what the state looks at for accountability. This is a little tricky because TrustLand Goals are due before we get EOY data.**

- a. Funding should focus on what is needed to achieve the goals we set in the TrustLand plan for next school year.
